***RENTAL AGREEMENT***

1. CHECK-IN TIME IS 4 PM. CST AND CHECK-OUT IS 10 A.M. MST.

*Owner hereby leases to resident, and resident hereby leases from the owner, the premises known as Dolomite Town House, Unit #10, 650 South Monarch Street, State of Colorado, subject to the terms and provisions hereof, for the term beginning on ..... 20\_\_ and ending on ..... 20\_\_.*

2. This is a NON SMOKING unit

3. Pets are not permitted in rental units under any conditions.

4. SECURITY DEPOSIT: A security deposit equivalent to 25% of the rent as a damage deposit is required 30 days prior arrival. The damage deposit is NOT applied toward rent; however, it is fully refundable within (14) days of departure, provided the following provisions are met.

- No pets have been allowed in the premises and have soiled any part of the property
- No physical damage has been done by guests to any portion of the property.

**RENT PAYABLE/DEPOSITS** RENTER agrees to pay to owner for time stayed at the above listed luxury vacation rental. The Rent is payable with a non-refundable deposit of 50% at the time of signing of this agreement, and the balance is due (30) days prior to your arrival. These rates are based on the time that you selected on the reservation order form you placed on line at [www.RentalAspen.com](http://www.RentalAspen.com) and at the end of this rental agreement. Rent is payable by wire, by credit card or by check, by check only for the first deposit and if 90 days prior arrival.

**CANCELLATIONS** – A minimum sixty (60) day notice is required for cancellation, please. Cancellations that are made more than sixty (60) days prior to the arrival date will incur no penalty. Cancellations or changes that result in a shortened stay, that are made within 60 days of the arrival date, forfeit the reservation deposit.

**MAXIMUM OCCUPANCY** – The maximum number of guests per condominium is limited to ten (10) persons. THIS PROPERTY REQUIRES A SEVEN (7) DAY MINIMUM STAY.

**UTILITIES** – Owner shall pay for electricity, gas, water, sewer, garbage, cable TV, master TV antenna. Resident shall pay for all other utilities and related deposits and for all charges on resident's utility bills including long distance charges.

**EQUIPMENT** – The premises are equipped with kitchen, dishwasher, washing machine, linens, towels, and color TV, washer/dryer, telephone, stereo, microwave, pc/printer/fax and high speed wireless internet.

**ACCESS** – RENTER shall allow owner access at reasonable times to the apartment for the purpose of inspection, or to show the apartment to prospective residents of the or to any other person having a legitimate interest therein, or make necessary repair or improvements. Resident agrees that in case of owner may enter the apartment without consent of resident.

**OWNER'S LIABILITY** – OWNER and RENTER further agree that owner will not be liable for any damages or losses to person or property caused by other residents, or person, theft, burglary, assault, vandalism, or other crimes. OWNER shall not be liable for personal injury or for damage to or loss of resident's personal property (furniture, jewelry, clothing, etc.) from fire, flood, water leaks, rain, hail, ice, snow, smoke, explosions, interruption of utilities, or acts of God. Resident hereby undertakes to indemnify, defend and hold harmless OWNER, his heirs, representatives, successors and assigns, from and against any and all loss, damage, claims, suits or actions at law, judgments and costs, including attorneys' fees reasonably incurred, which may arise or grow out of any injury to persons or damage to property caused by, arising from or in any manner connected with RENTER's occupancy of the premises

**FALSIFIED RESERVATIONS** – Any reservation obtained under false pretense will be subject to forfeiture of advance payment, deposit and/or rental money, and the RENTER will not be permitted to check-in.

**WRITTEN EXCEPTIONS** – Any exceptions to the above mentioned policies must be approved in writing in advance.
